NOTICE REGARDING CREMATED REMAINS: A person having the right to control disposition of cremated remains may remove the remains in a durable container from the place of cremation or interment, pursuant to section 7054.6 of the Health and Safety Code.

If the cremated remains container cannot accommodate all the cremated remains of the deceased, the crematory shall provide a larger cremated remains container at no additional cost, or place the excess in a second container that cannot easily come apart from the first, pursuant to section 8345 of the Health and Safety Code.

### **Basic Services of the Funeral Director and Staff**

Our basic service charge includes, but is not limited to, staff to respond to initial request for service; Arrangements conference with family or responsible party; preparation and filing of necessary certificates and permits; shelter of remains; placement of obituary notices, planning of funeral arrangements; and coordination of service with cemetery, crematory, vault companies and others as required.

### **Embalming**

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as a direct cremation or immediate burial
