The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. **However, any funeral arrangements you select will include a charge for our basic services and overhead.** If legal or other requirements mean you must purchase any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

All services outlined are based on a 30 mile radius from our home office. Extra fees may apply for additional mileage and excess travel time. As a service to all our families, we provide a complimentary service announcement on our website to let the community know whether there are public services or not.

"Prior to drafting any contract for goods or services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any preneed agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent."

Methods of Payment:

Payment for goods and services is expected prior to the services being rendered. For your convenience we accept cash, check and credit cards (Visa, MasterCard, Discover and American Express) although with the use of a debit or credit card there is a 3% processing fee added to the total charge. We also accept the use of Life Insurance Policies as a guarantee of payment. If accepted, an insurance assignment processing fee of 5% or a minimum of \$125 will be charged.

Basic Services of Funeral Director and Staff

Our services include coordinating with the person(s) with right of control; collecting necessary information to complete required paperwork by the use of phone, email and electronic signature; obtaining necessary authorizations and permits for disposition; coordinating with crematory, cemetery or other third parties. In addition, this fee includes a proportionate share of our basic overhead costs. This fee for our basic services and overhead will be added to the total cost of the arrangements you select, although it is already included in our charges for direct cremation, immediate burial, forwarding and receiving of remains.

Embalming

Not offered

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

Direct Cremation

Our charge for a direct cremation (without ceremony) includes: virtual services of funeral director and staff; a proportionate share of overhead costs; transfer of deceased to funeral home; refrigeration up to 7 days, minimum cardboard cremation container, the standard cremation fee and a temporary container for the cremated remains (ashes).

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are made of these materials and interiors may be added.

Immediate Burial

\$1195 - \$4590

Immediate burial is the minimum service offered for disposition of remains in a cemetery. This service includes: virtual services of funeral director and staff; a proportionate share of overhead costs; transfer of deceased to funeral home; refrigeration up to 7 days, placing shrouded remains into casket selected (purchased separately) and delivery for committal. This is a non-witnessed or attended interment.

Forwarding of Remains *(not available for all destinations)*
